VII. Financial Report

A. Mr. Chris Bentley reported for December 2024 the total unrestricted cash and investments was \$8,117,649.81. Total revenue was \$13,512,360.02. The net income was \$4,655,467.76 which included RCAP and sale proceeds. The total cost for the Walnut Street Project was \$6,788.755.49. Mr. Mark Jobes asked for a motion to approve the financials for December 2024. Ms. Karen Widrick made a motion to approve the financials and Mr. Eugene Gonzalez seconded it. A motion was passed unanimously.

A. Capital Repair Projects

1. THA did a five-year assessment of all the Bethlehem Parking Authority's assets which helped prepare the 5-year Capital Repair Program. Last year what was presented to the Budget was \$564,000.00 in repairs to the Riverport Garage. It was a two-year project to be done in 2025/2026. Late last year the Maintenance Department noticed significant leaks and water flowing at the S. New Street Garage from the top level. Mr. Ryan Klass from THA did an assessment and provided a summary of the findings. Significant repairs were needed on the T-joints and sealants on the top level of the S. New Street Garage. The repairs for the S. New Street Garage were an estimated \$250,000.00. The leftover funds are to be used for the Riverport Garage. Mr. Mark Jobes asked for a motion to approve the proposal from THA. Mr. Eugene Gonzalez made a motion and Ms. Karen Widrick seconded it. A motion was passed unanimously.
